**NOTIFICATION**

S.O.... In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, namely:-

In the said First Schedule -

a) after "Bhupendra Narayan Mandal University, Madhepur, Bihar", "Al-Karim University, Katihar" shall be added and against "Al-Karim University, Katihar" under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2) ] and under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Bachelor of Medicine and Bachelor of Surgery"	MBBS (This shall be a recognized medical qualification when granted by Bhupendra Narayan Mandal University, Madhepura, Bihar upto the academic session 2017-18 and thereafter by Al-Karim University, Katihar from the academic session 2018-19 in respect of students being trained at Katihar Medical College, Katihar.
