**Important Notice for 2nd round Counselling (Medical)**

In continuation to earlier published all concerned advertisements of PGMAC-2020, this is to inform all qualified, eligible and interested NEET-PG 2020 candidates who have not duly filled the online application for PGMAC-2020 vide Adv. No.-BCECEB(PGMAC)-2020/01 and 02 Dated 17.04.2020 and 2020/05 Dated 11.07.2020 due to any reason and want to attend 2nd round counselling can do fresh registration and submit online application form through visiting the link "**Online Application Portal of PGMAC-2020**" and by Clicking "**Apply Online**" button from Board's website: [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in).

2. The detailed procedure / instructions for registration and submission of online application form can be obtained from the Adv. No.-BCECEB(PGMAC)-2020/02 Dated: 17.04.2020 uploaded on the Board's website.

3. Those candidates, who have duly filled Online Application Form of PGMAC-2020 earlier, need not apply again.

4. Those candidates, who have successfully done the registration but due to any reason could not fill their online application form completely with payment of counselling fee can also login to their account and complete their rest steps through visiting the link "Online Application Portal of PGMAC-2020" and by clicking "Apply Online" button from Board's website : [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) .

5. (i) Those candidates, who have been allotted and their documents got duly verified as well as admitted against allotted seat by concerned participating institute and have not given willingness for upgradation but want to resign from allotted and admitted seat on the basis of 1st round counselling can give their resignation online as per programme given below. To become eligible for 2nd round counselling, he/she must have to give their willingness for attending 2nd round of counselling and have to fill fresh choices as per programme given below. **The paid Fee of such candidates will be forfeited.** Such candidates who have resigned from their 1st round allotted and admitted seat will not be given the same seat in the same institution in the 2nd round.

(ii) Those candidates, who have registered and filled choices but have not been allotted any seat in 1st round, have to give their willingness for attending 2nd round of counselling and have to fill fresh choices as per programme given below.

(iii) Those candidates, who have been allotted a seat in 1st round but due to any reason unable to do online reporting i.e. fail to upload documents or required fee payment is also eligible for 2nd round but they also have to give their willingness for attending 2nd round of counselling and have to fill fresh choices as per programme given below.

(iv) Those candidates who were allotted a seat but due to any reason, the discrepancy generates and they become ineligible for 1st round, are also eligible for 2nd round but they also have to give their willingness for attending 2nd round of counselling and have to fill fresh choices as per programme given below.

(v) All eligible candidates of PGMAC-2020 willing to participate in second round counselling, have to fill fresh choices during choice filling as per programme given below and their previous filled choices for 1st round will become null and void. **It is mandatory.** Candidates who have been allotted seat in first round and got their documents successfully verified and have already given willingness for upgradation, must include the seat allotted to them in their 2nd round choice filling otherwise they will lose the allotted seat of first round.

Above candidates are directed to visit the link "Online Counselling Portal of PGMAC-2020" and by clicking "**Link for resigning 1st round allotted and admitted Seat / Willingness for attending 2nd round of counselling**" from Board's website [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) . After that candidate will be re-directed to the PGMAC-2020 online counselling portal where they can login to their account and do the activity for Resigning / Willingness for attending 2nd round counselling as programme given below and for choice filling click on the "**Link for Fresh Registration and Choice Filling of PGMAC-2020 Medical 2nd Round Counselling**" from Board's website : [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) as per programme given below.

If a candidate fails to do so, the candidate will be fully responsible for it and neither any extra time will be given nor any request will be entertained in this regard.

6. Those NEET(PG)-2020 qualified & eligible candidates ;

(i) who have already duly filled the online application form of PGMAC-2020 vide Adv. No. BCECEB(PGMAC)-2020/01 & 2020/02 dated 17.04.2020 and 2020/05 dated 11.07.2020 but did not do the registration and choice filling process for PGMAC-2020 1st round counselling can also do the registration and choice filling for 2nd round.

(ii) who will duly fill fresh Online Application Form for PGMAC-2020 2nd round vide this Adv. No. BCECEB(PGMAC)-2020/17 dated 06.08.2020 have also to do the fresh registration and choice filling for 2nd round.

They are directed to visit the link "Online Counselling Portal of PGMAC-2020" and by clicking "**link for Fresh Registration and Choice filling of PGMAC-2020 Medical 2nd Round Counselling**" from Board's website

bceceboard.bihar.gov.in . After that candidate will be re-directed to the PGMAC-2020 online counselling portal where they can do the registration and after successful registration login to their account and do the activity for choice filling as per programme given below.

7. As per Notice no.-12021/44/2019/54-MEC dated 23.06.2020, Directorate General of Health Services, Government of India, the Candidates holding PG Course (Degree/Diploma) seat in round-2 of all India Quota / Deemed University are not eligible to participate in any other Counselling.

8. The seat matrix with vacant seats will be displayed on Board's website before choice filling. However, candidates are advised to fill all the choices they want as during the seat allotment process, new vacancies can be created.

9. This is to inform all qualified and eligible NEET(PG)-2020 candidates who have duly filled the online application form of PGMAC-2020 vide Adv. no. BCECEB(PGMAC)-2020/01 and 02 Dated 17.04.2020 and 2020/05 Dated 11.07.2020 and claimed reservation for serving as Medical officer in Remote / Difficult area as "Yes" or "No" can edit their remote serving related data as per programme given below by clicking the link "Online Application Portal of PGMAC-2020" as per programme given below and click "**Apply Online**" button and login to account by entering registered email ID and Password by clicking "**Sign In**" button. After successful login, click on "**Application for M.O. Employed Candidates**" button and fill the required informations as asked on the screen and upload the required experience certificate (**See Annexure-3 & 3A of PGMAC-2020 Updated Revised Prospectus**). Click on "**Save**" button. Candidates are also advised to download or take a print out of filled application for further use. If any candidate fails to upload the remote area working experience certificate, he/she will not be considered for reservation for remote/difficult area.
