Essentiality Certificate- Course: MBBS

Sir,

The desired certificate is as follows:-

- (1) It is certified that the Katihar Medical College, Katihar, Bihar is recognized u/s 11(2) of the IMC Act, 1956 for 100 (one hundred) seats.
- (2) No. of Institutions already existing in the State:- 14 (9 Govt. & 5 Private Medical Colleges)
- (3) No. of institutions offering MBBS course:- 14 (9 Govt. & 5 Private Medical Colleges)
- (4) No. of seats available in the MBBS course in the State:- 1740 (1140+600)
- (5) Full justification for instituting the MBBS course:- The proposed increased in number of MBBS seats is justified considering the present Doctor Population ratio and also with a view to achieve healthy Doctor Population ratio in the State.

The Katihar Medical College, Katihar has applied for opening the course of MBBS. On careful consideration of the proposal, the Government of Bihar has decided to issue an essentiality certificate to the applicant for the opening/ increase of seats in the above said course with 150 (one hundred fifty) seats.

It is certified that:-

- (a) It is desirable to open/increase of seats in course of MBBS in the public interest.
- (b) Opening/ increase of seats in the course of MBBS at Katihar by Katihar Medical College is feasible.
- (c) The institution in the said department is having the following faculty- List enclosed.
- (d) The institution in the said department is having 590 beds in 20 units and adequate clinical material as per the Medical Council of India norms is available.

It is further certified that in case the applicant fails to create infrastructure for the course as per MCI norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the above said course at this college with the permission of the Central Government.
