

NRI DOCUMENTS REQUIRED FOR ADMISSION UNDER NRI CATEGORY

Note: Latest direction issued by Govt. of India/NMC/MCC/BCECE Board time to time will be applicable. Candidates and guardians are advised to remain in touch with all concerned authorities through their website.

Additional documents for NRI/OCI students only:

i) NEET-UG Admit Card and Score Card

ii) Proof of NRI Status of the parent/relative:

- Valid Passport
- Visa / Residence Permit / Work Permit
- Overseas Citizen of India (OCI) card / PIO card, if applicable
- NRI Certificate issued by the Competent Authority (Embassy / Indian Consulate).
- NRE (Non-Resident External) Bank Account Pass Book.

iii) Certificate of Relationship between the NRI relative and the candidate issued by the competent Revenue Authority through Family Tree*.

iv) Affidavit (Notarized) by the NRI relative stating that they will sponsor the entire course fee and living expenses of the candidate during the period of study duly supported by NRE (Non-Resident External) Bank Account Pass Book.

v) 10th & 12th mark sheets + passing certificate

vi) Birth certificate

vii) Passport of candidate/ Sponsorer (optional)

*Family tree issued by Competent Revenue Authority i.e. SDM/Tehsildar/Circle Officer/Revenue Officer establishing relation between the Sponsor and the candidate.

- a. First degree relation i.e. Father, Mother, Brother, Sister
- b. Real brother and real sister of father i.e. real uncle and real aunt
- c. Real brother and real sister of mother i.e. real maternal uncle and real maternal aunt
- d. Father and mother of father i.e. grand father and grand mother
- e. Father and mother of mother i.e. maternal grand father and maternal grand mother
- f. First degree paternal and maternal cousins i.e son/daughter of Brother, Sister, real uncle and real aunt, real maternal uncle and real maternal aunt
- g. Such person should be NRI
